# Liquefied Petroleum Gas Board Minutes April 11, 2024

The Alabama Liquefied Petroleum Gas Board held its quarterly board meeting on April 11, 2024, at 10:00 a.m. at 770 S. McDonough Street, Montgomery, AL.
