

Liquefied Petroleum Gas Board Minutes
April 10, 2025

The Alabama Liquefied Petroleum Gas Board held its quarterly board meeting on April 10, 2025, at 10:00 a.m. at 7840 Halcyon Pointe Drive, Bldg. III Montgomery, AL

With a quorum present, the Chairman called the meeting to order and gave the invocation.

The Chairman called for a motion to adopt the agenda.

(1) Mr. Ferguson moved to adopt the agenda. Seconded by Mr. Brown, the ayes were unanimous.

He stated that the facility posed an imminent threat to the community and was not in the correct location. Also, Mr. Marchant said Amerigas had a complaint in 2015 and another in 2023. In addition, he stated that he would like the license to be revoked. Mr. Marchant also stated that their business license had been suspended. He reiterated that they have a petition with a thousand signatures to remove the facility from the community.
